**4. FIRST-AID MEASURES**

**4.1 Description of necessary first-aid measures**

**General advice**

**If inhaled**

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

**Following skin contact**

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

**Following eye contact**

Rinse with pure water for at least 15 minutes. Consult a doctor.

**Following ingestion**

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

**4.2 Most important symptoms/effects, acute and delayed**

Treatment of overdose: Treatment is essentially symptomatic and supportive. To decrease absorption: .../adminster/ activated charcoal. Specific treatment: Counteracting hypotension and circulatory collapse by use of intravenous fluids, plasma, or concentrated albumin, and vasopressor agents such as norepinephrine. Epinephrine should not be used since it may cause paradoxical hypotension. Administering benzotropine or diphenhydramine to manage severe extrapyramidal reactions. Monitoring: Monitoring ECG for signs of Q-T prolongation or torsades de pointes. Severe arrhythmias should be treated with appropriate antiarrhythmic measures. Supportive care: Establishing a patent airway. Mechanically assisting respiration, if necessary. Patients in whom intentional over dose is known or suspected should be referred for psychiatric consultation. Note: Dialysis is not effective in removing excessive systemic haloperidol.

### 6. ACCIDENTAL RELEASE MEASURES

#### 6.1 Personal precautions, protective equipment and emergency procedures

Avoid dust formation. Avoid breathing mist, gas or vapours. Avoid contacting with skin and eye. Use personal protective equipment. Wear chemical impermeable gloves. Ensure adequate ventilation. Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

#### 6.2 Environmental precautions

Prevent further spillage or leakage if it is safe to do so. Do not let the chemical enter drains. Discharge into the environment must be avoided.

#### 6.3 Methods and materials for containment and cleaning up

Collect and arrange disposal. Keep the chemical in suitable and closed containers for disposal. Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.

### 7. HANDLING AND STORAGE

#### 7.1 Precautions for safe handling

Handling in a well ventilated place. Wear suitable protective clothing. Avoid contact with skin and eyes. Avoid formation of dust and aerosols. Use non-sparking tools. Prevent fire caused by electrostatic discharge steam.

#### 7.2 Conditions for safe storage, including any incompatibilities

Store the container tightly closed in a dry, cool and well-ventilated place. Store apart from foodstuff containers or incompatible materials.

### 12.3 Bioaccumulative potential

An estimated BCF of 59 was calculated for haloperidol(SRC), using a log Kow of 4.30(1) and a regression-derived equation(2). According to a classification scheme(3), this BCF suggests the potential for bioconcentration in aquatic organisms is moderate(SRC).

### 12.4 Mobility in soil

The Koc of haloperidol is estimated as 5,200(SRC), using a log Kow of 4.3(1) and a regression-derived equation(2). According to a classification scheme(3), this estimated Koc value suggests that haloperidol is expected to be immobile in soil. The pKa of haloperidol is 8.66(1), indicating that this compound will exist primarily in the protonated form in the environment and cations generally adsorb more strongly to organic carbon and clay than their neutral counterparts(4).

### 13. DISPOSAL CONSIDERATIONS

#### 13.1 Disposal methods

##### Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

##### Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
