4. FIRST-AID MEASURES

4.1 Description of necessary first-aid measures

General advice

If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a d°ctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

Following skin contact

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a d°ctor.

Following eye contact

Rinse with pure water for at least 15 minutes. Consult a d°ctor.

Following ingestion

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a d°ctor or Poison Control Center immediately.

Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

12.2 Persistence and degradability

AEROBIC: No biodegradation data were l°Cated for 3-chlorophenoxyacetic acid, although biodegradation data were l°Cated for the other isomers 2-, and 4-chlorophenoxyacetic acid(SRC, 2006). 2-Chlorophenoxyacetic acid was completely degraded in 47, 124, and 205 days in a Honeoye silt loam, Mardin silt loam, and Dunkirk silt loam, respectively, while 4-chlorophenoxyacetic acid was completely degraded in the Honeoye and Dunkirk soils in 94 and 11 days, respectively(1). The time required for 80% degradation of 2-chlorophenoxyacetic acid in soil was >360 days in fresh soil and 31.8 days in a soil adapted to MPCA(2). The time required for 80% degradation of 4-chlorophenoxyacetic acid in soil was 12.1 days in fresh soil and 2.5 days in adapted soil(2).

12.4 Mobility in soil

Using a structure estimation method based on molecular connectivity indices(1), the K^oC for 3-chlorophenoxyacetic acid can be estimated to be 18(SRC). According to a classification scheme(2), this estimated K^oC value suggests that 3-chlorophenoxyacetic acid is expected to have very high mobility in soil(SRC). In addition, the pKa of 3-chlorophenoxyacetic acid is 3.07(3), indicating that this compound will primarily exist as an anion in the environment, and anions generally possess high mobility in soil(4).

13.1 Disposal methods

Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
