## 4. FIRST-AID MEASURES

### 4.1 Description of necessary first-aid measures

#### General advice

#### If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a d°ctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

#### Following skin contact

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a d°ctor.

#### Following eye contact

Rinse with pure water for at least 15 minutes. Consult a d°ctor.

#### Following ingestion

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a d°ctor or Poison Control Center immediately.

### 4.2 Most important symptoms/effects, acute and delayed

Immediate first aid: Ensure that adequate decontamination has been carried out. If patient is not breathing, start artificial respiration, preferably with a demand valve resuscitator, bag-valve-mask device, or p°cket mask, as trained. Perform CPR if necessary. Immediately flush contaminated eyes with gently flowing water. Do not induce vomiting. If vomiting °ccurs, lean patient forward or place on the left side (head-down position, if possible) to maintain an open airway and prevent aspiration. Keep patient quiet and maintain normal body temperature. Obtain medical attention. Poisons A and B

## 6. ACCIDENTAL RELEASE MEASURES

### 6.1 Personal precautions, protective equipment and emergency procedures

Avoid dust formation. Avoid breathing mist, gas or vapours. Avoid contacting with skin and eye. Use personal protective equipment. Wear chemical impermeable gloves. Ensure adequate ventilation. Remove all sources of ignition. Evacuate personnel to safe areas. Keep people

away from and upwind of spill/leak.

Prevent further spillage or leakage if it is safe to do so. Do not let the chemical enter drains. Discharge into the environment must be avoided.

### 6.3 Methods and materials for containment and cleaning up

Collect and arrange disposal. Keep the chemical in suitable and closed containers for disposal. Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.

Handling in a well ventilated place. Wear suitable protective clothing. Avoid contact with skin and eyes. Avoid formation of dust and aerosols. Use non-sparking tools. Prevent fire caused by electrostatic discharge steam.

Store the container tightly closed in a dry, cool and well-ventilated place. Store apart from foodstuff containers or incompatible materials.

## **12. ECOLOGICAL INFORMATION**

### **12.1 Toxicity**

### **12.2 Persistence and degradability**

AEROBIC: In 22-day aerobic river die-away tests using several river water samples in 24 micr°Cosms, bisphenol B showed no degradation in 12 micr°Cosms and incomplete degradation in 12 micr°Cosms. In anaerobic biodegradation tests using pond sediment, bisphenol B showed no degradation over the initial 60 days of incubation; after 84 days, approximately 60% of initial bisphenol B still remained(1).

### **12.3 Bioaccumulative potential**

An estimated BCF of 250 was calculated in fish for bisphenol B(SRC), using an estimated log Kow of 4.13(1) and a regression-derived equation(1). According to a classification scheme(2), this BCF suggests the potential for bi°Concentration in aquatic organisms is high (SRC).

### **12.4 Mobility in soil**

Using a structure estimation method based on molecular connectivity indices(1), the K°C of bisphenol B can be estimated to be 7.4X10+4 (SRC). According to a classification scheme(2), this estimated K°C value suggests that bisphenol B is expected to be immobile in soil. The estimated pKa of bisphenol B is 10.2(3), indicating that this compound will exist predominately in the non-ionized form in the environment(SRC); the anion form of bisphenol B is not expected to adsorb more strongly to soils containing organic carbon and clay than the neutral counterpart(3).

## **13. DISPOSAL CONSIDERATIONS**

### **13.1 Disposal methods**

#### **Product**

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

#### **Contaminated packaging**

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
