4. FIRST-AID MEASURES

4.1 Description of necessary first-aid measures

General advice

If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a doctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

Following skin contact

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a doctor.

Following eye contact

Rinse with pure water for at least 15 minutes. Consult a doctor.

Following ingestion

Rinse mouth with water. Do not induce vomiting. Never give anything by mouth to an unconscious person. Call a doctor or Poison Control Center immediately.

4.2 Most important symptoms/effects, acute and delayed

Immediate first aid: Ensure that adequate decontamination has been carried out. If patient is not breathing, start artificial respiration, preferably with a demand-valve resuscitator, bag-valve-mask device, or pocket mask, as trained. Perform CPR as necessary. Immediately flush contaminated eyes with gently flowing water. Do not induce vomiting. If vomiting occurs, lean patient forward or place on left side (head-down position, if possible) to maintain an open airway and prevent aspiration. Keep patient quiet and maintain normal body temperature. Obtain medical attention. Aldehydes and Related Compounds

6. ACCIDENTAL RELEASE MEASURES

6.1 Personal precautions, protective equipment and emergency procedures

Avoid dust formation. Avoid breathing mist, gas or vapours. Avoid contacting with skin and eye. Use personal protective equipment. Wear chemical impermeable gloves. Ensure adequate ventilation. Remove all sources of ignition. Evacuate personnel to safe areas. Keep people away from and upwind of spill/leak.

Prevent further spillage or leakage if it is safe to do so. Do not let the chemical enter drains. Discharge into the environment must be avoided.

6.3 Methods and materials for containment and cleaning up

Collect and arrange disposal. Keep the chemical in suitable and closed containers for disposal. Remove all sources of ignition. Use spark-proof tools and explosion-proof equipment. Adhered or collected material should be promptly disposed of, in accordance with appropriate laws and regulations.

Handling in a well ventilated place. Wear suitable protective clothing. Avoid contact with skin and eyes. Avoid formation of dust and aerosols. Use non-sparking tools. Prevent fire caused by electrostatic discharge steam.

Store the container tightly closed in a dry, cool and well-ventilated place. Store apart from foodstuff containers or incompatible materials.

12. ECOLOGICAL INFORMATION

12.1 Toxicity

Toxicity to fish: LC50 - 0.91 mg/L - 96 h.

Toxicity to daphnia and other aquatic invertebrates: EC50 - Daphnia sp. - 0.28 mg/L - 48 h.

Toxicity to algae: EC50 - > 1.5 mg/L - 72 h.

Toxicity to microorganisms: MIC - *Corynebacterium minutissimum* (CM), *Arthrobacter* sp. isolated from Lipo-66, *Staphylococcus aureus* (IAM-1011, (SA)), *Staphylococcus epidermidis* var. (SE) and *Escherichia coli* (ATCC 11775, (EC)) - > 2 000 mg/L - 24 h.

12.2 Persistence and degradability

AEROBIC: alpha-Amyl cinnamaldehyde, present at 100 mg/L, reached 51% of its theoretical BOD in 4 weeks using an activated sludge inoculum at 30 mg/L in the Japanese MITI test(1). Using OECD Method 301B (CO2 evolution), alpha-amyl cinnamaldehyde had a 65% degradation in 28 days indicating it was readily biodegradable(2). Using OECD Method 301F (Respirometric method/SAPROMAT), alpha-amyl cinnamaldehyde had a 90% degradation 28 days indicating it was readily biodegradable(2).

12.3 Bioaccumulative potential

An estimated BCF of 586 was calculated in fish for alpha-amyl cinnamaldehyde(SRC), using a log Kow of 4.70(1) and a regression-derived equation(2). According to a classification scheme(3), this BCF suggests the potential for bioconcentration in aquatic organisms is high (SRC), provided the compound is not metabolized by the organism(SRC).

12.4 Mobility in soil

Using a structure estimation method based on molecular connectivity indices(1), the Koc of alpha-amyl cinnamaldehyde can be estimated to be 680(SRC). According to a classification scheme(2), this estimated Koc value suggests that alpha-amyl cinnamaldehyde is expected to have low mobility in soil.

13. DISPOSAL CONSIDERATIONS

13.1 Disposal methods

Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
