#### General advice

If patient is not breathing, start artificial respiration, preferably with a demand valve resuscitator, bag-valve-mask device, or pocket mask, as trained. Perform CPR if necessary. Immediately flush contaminated eyes with gently flowing water. Do not induce vomiting. If vomiting occurs, lean patient forward or place on the left side (head-down position, if possible) to maintain an open airway and prevent aspiration. Keep patient quiet and maintain normal body temperature. Obtain medical attention. Poisons A and B

#### 12.2 Persistence and degradability

AEROBIC: Salinomycin was degraded 50-70% in soil in 7 day aerobic studies, 20-25% was attributed to abiotic reactions and the remaining portion was considered biodegradation(1). Salinomycin had a degradation half-life of 5 days under aerobic conditions in soil (2). Salinomycin had a degradation half-life of 6 days under anaerobic conditions at 20 deg C, digested in liquid manure(3).

#### 12.3 Bioaccumulative potential

An estimated BCF of 10 was calculated in fish for salinomycin(SRC), using an estimated log Kow of 8.53(1) and a regression-derived equation(1). According to a classification scheme(2), this BCF suggests the potential for bioconcentration in aquatic organisms is low (SRC).

#### 12.4 Mobility in soil

Using a structure estimation method based on molecular connectivity indices(1), the Koc of salinomycin can be estimated to be 6050 (SRC). According to a classification scheme(2), this estimated Koc value suggests that salinomycin is expected to be immobile in soil. The estimated pKa of salinomycin is 4.5(3), indicating that this compound will exist almost entirely in anion form in the environment and anions generally do not adsorb more strongly to soils containing organic carbon and clay than their neutral counterparts(4).

#### 13.1 Disposal methods

#### **Product**

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

#### Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
