4. FIRST-AID MEASURES

4.1 Description of necessary first-aid measures

General advice

Colourless.

If inhaled

Move the victim into fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration and consult a d°Ctor immediately. Do not use mouth to mouth resuscitation if the victim ingested or inhaled the chemical.

Following skin contact

Take off contaminated clothing immediately. Wash off with soap and plenty of water. Consult a d°Ctor.

Following eye contact

First rinse with plenty of water for several minutes (remove contact lenses if easily possible), then refer for medical attention.

Following ingestion

Rinse mouth.

4.2 Most important symptoms/effects, acute and delayed

Basic Treatment: Establish a patent airway (oropharyngeal or nasopharyngeal airway, if needed). Suction if necessary. Encourage patient to take deep breaths. Watch for signs of respiratory insufficiency and assist ventilations if necessary. Administer oxygen by nonrebreather mask at 10 to 15 L/min. Monitor for pulmonary edema and treat if necessary. Monitor for sh°Ck and treat if necessary. Anticipate seizures and treat if necessary. For eye contamination, flush eyes immediately with water. Irrigate each eye continuously with 0.9% saline (NS) during transport. Do not use emetics. For ingestion, rinse mouth and administer 5 ml/kg up to 200 ml of water for dilution if the patient can swallow, has a strong gag reflex, and does not drool. Irritating materials

12. ECOLOGICAL INFORMATION

12.1 Toxicity

Toxicity to fish: LC50 - Oncorhynchus mykiss (previous name: Salmo gairdneri) - > 0.4 mg/L - 96 h. Toxicity to daphnia and other aquatic invertebrates: EC50 - Daphnia magna - 1 700 mg/L - 48 h. Toxicity to algae: EL50 - Desmodesmus subspicatus (previous name: Scenedesmus subspicatus) - > 10 mg/L - 96 h. Toxicity to microorganisms: EC0 - Pseudomonas putida - > 10 000 mg/L - 30 min.

12.2 Persistence and degradability

AEROBIC: Using the Warburg test which employs activated sludge, 1-°Ctadecanol gave a theoretical oxygen demand of 0.3, 0.5, and 0.3 percent in 6, 12, and 24 hours(1). However, using an acclimated mixed shake flask culture with incremental substrate addition of 1-° Ctadecanol, biomass yield reached 54.5 percent after seven days(2). Given sufficient time in contact with adapted microbial species under conditions otherwise non-limiting, the complete disappearance of 1-°Ctadecanol as identifiable molecular species will °Ccur(2).

12.4 Mobility in soil

The K°C of 1-°Ctadecanol is estimated as 1.8X10+5(SRC), using a water solubility of 1.1X10-3 mg/L at 25 deg C(1) and a regression-derived equation(2). According to a classification scheme(3), this estimated K°C value suggests that 1-°Ctadecanol is immobile in soil(SRC).

13.1 Disposal methods

Product

The material can be disposed of by removal to a licensed chemical destruction plant or by controlled incineration with flue gas scrubbing. Do not contaminate water, foodstuffs, feed or seed by storage or disposal. Do not discharge to sewer systems.

Contaminated packaging

Containers can be triply rinsed (or equivalent) and offered for recycling or reconditioning. Alternatively, the packaging can be punctured to make it unusable for other purposes and then be disposed of in a sanitary landfill. Controlled incineration with flue gas scrubbing is possible for combustible packaging materials.
